

JUDGMENT

The testimony of Dr. Harold M. Lowe was provided via deposition. The matter was taken under advisement and a decision was rendered on February 27, 2015 and filed with the clerk's office in this matter. A copy of the decision granting damages to Mark Mangano and Randa Mangano in the amount of \$65,000 is attached hereto and incorporated herein by reference as fully as if copied verbatim.


